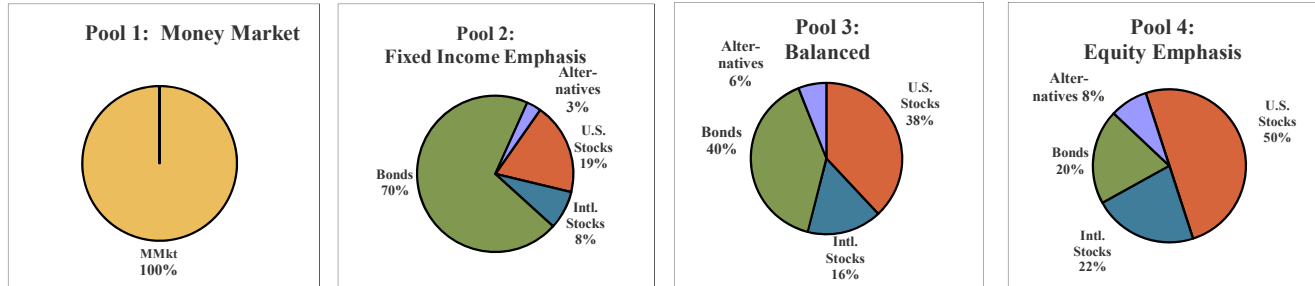

Domestic Equities: Total Market <i>Vanguard Total Stock Market Index Fund</i> Passive investment that seeks to replicate the performance of the CRSP U.S. Total Market Index. The Index represents approximately 100% of the investable U.S. stock market including large-, mid-, and small-capitalization companies regularly traded on the New York Stock Exchange and Nasdaq national markets.	0%	19%	38%	50%

Fixed Income: Short-Term <i>Vanguard Short-Term Bond Index Fund</i> Passive investment that seeks to replicate the performance of the Barclays U.S. 1-5 Year Government/Credit Float Adjusted Index. Fixed Income: Intermediate-Term <i>Vanguard Intermediate-Term Bond Index Fund</i> Passive investment that seeks to replicate the performance of the Barclays U.S. 5-10 Year Government/Credit Float Adjusted Index. Alternative Investments: REIT <i>Vanguard REIT Index Adm</i> Passive investment that seeks to replicate the performance of the MSCI U.S. REIT Index. Alternative Investments: MLP ETN <i>JPMorgan Alerian MLP Index Exchange Traded Note</i> Passive investment that seeks to replicate the Alerian MLP Index.
