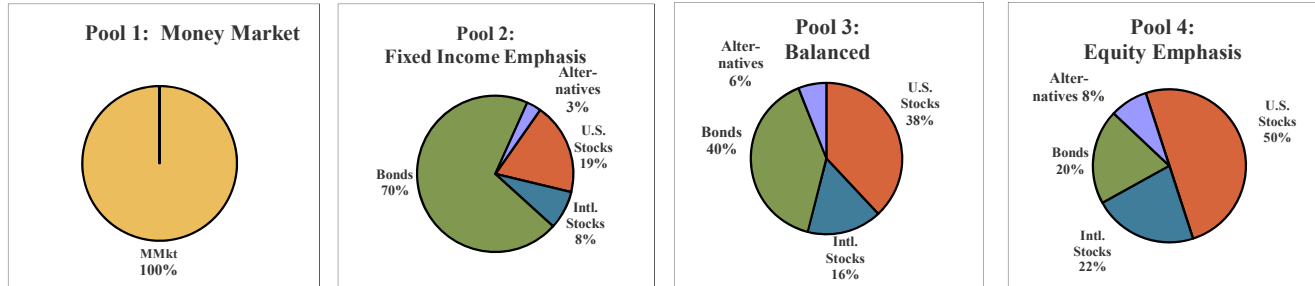

Domestic Equities: Total Market <i>Vanguard Total Stock Market Index Fund</i> Passive investment that seeks to replicate the performance of the CRSP U.S. Total Market Index. The Index represents approximately 100% of the investable U.S. stock market including large-, mid-, and small-capitalization companies regularly traded on the New York Stock Exchange and Nasdaq national markets.	0%	19%	38%	50%

Fixed Income: Short-Term <i>Vanguard Short-Term Bond Index Fund</i> Passive investment that seeks to replicate the performance of the Barclays U.S. 1-5 Year Government/Credit Float Adjusted Index. Fixed Income: Intermediate-Term <i>Vanguard Intermediate-Term Bond Index Fund</i> Passive investment that seeks to replicate the performance of the Barclays U.S. 5-10 Year Government/Credit Float Adjusted Index. Fixed Income: International <i>SPDR Barclays International Treasury Bond ETF</i> Passive investment that seeks to replicate the price and yield performance of the Barclays Global Treasury Ex-US Capped Index. Senior Bank Loans <i>iBoxx Senior Loan ETF</i> Passive investment that seeks to replicate the price and yield performance of the Markit iBoxx USD Liquid Leveraged Loan Index. The index consists of approximately 100 of the largest, most liquid leveraged senior bank loans in the U.S.	0%	0%	4%	3.50%
Alternative Investments: REIT <i>Vanguard REIT Index Adm</i> Passive investment that seeks to replicate the performance of the MSCI U.S. REIT Index. Alternative Investments: MLP ETN <i>JPMorgan Alerian MLP Index Exchange Traded Note</i> Passive investment that seeks to replicate the Alerian MLP Index. Money Market: <i>U.S. Government and Treasury Obligations Portfolio</i> Securities issued with the full faith and credit of the U.S. Government including U.S. Treasury Bills and Notes, and Certificate of Deposits issued by FDIC insured banks.
